Happy New Year everyone - here's to a fabulous 2024! Hope you all had a lovely festive/summer season.

2024 is off to a busy start with the Parks reaching an average occupancy over the peak period of 90%! During these busy times the Park teams work very hard to ensure the parks are looking great, everyone has an enjoyable summer holiday, and everyone returns home safe from their holiday. During this peak season and busy summer weekends in particular we have seen a significant increase of kids & adults riding bikes, electric scooters and other electric devices and often without helmets.

ALL of these electric vehicles are NOT permitted to be used in the parks at any time.

Whilst we have park rules in place and do our best to enforce them, it is challenging. We implore you and those in your care (including kids of all ages, teenagers & even adults who should know better) that the rules are in place for everyone's safety and enjoyment of the park & everyone needs to follow them. As Holiday Van owners we would encourage you to lead by example for other park users.

You have signed an Occupancy Agreement agreeing to all the terms and conditions, which includes following the rules.

It is incredibly frustrating to receive complaints & concerns from park users that they are wary, even scared to walk in the park, or even to go to the amenities because they may get knocked over by bikes/scooters that are being ridden on the roads & through and around the amenities and very often at great speed & exceeding the Park speed limit of 8kph.

The Port Stephens area has really not had any significant rain for months now, with the exception of the past couple of days.

If you would like to water your site whilst you are in house, please feel free to do so for <u>no more than an hour</u> either in the morning or later in the evening, this will greatly assist our grounds staff. However, please be mindful that all taps are connected to town water, so please do not leave sprinklers or soaker hoses running for hours and hours, as overwatering only makes the grass roots shallow and more susceptible to dying in times of low rainfall.

Just a reminder to ensure gazebos/frames and makeshift awnings are not left erected after you have departed the



park. Thanks.

To avoid confrontation with your neighbours, or wasting our time when trying to find who has illegally parked, please ensure you park in your own allocated car space and not on someone else's or on a spare site. The park is still busy, and most sites are booked out especially on weekends.

Halifax Holiday Park now has number plate recognition on their boom gates. An email will be sent round in due course requesting everyone update their number plate details. This system works in conjunction with the Gate Code system.
