If you need to speak with someone during my absence & before my return, please call 4988 0990 and choose Option 2 for Existing booking. This will generally put you through to the park reception, or reservations if the park is busy.

If you choose Option 4 for Holiday Van Owners, or call my direct line (4988 0650) it will divert you to Fingal Bay front desk.

Reminders:

Enjoy the Spring School Holidays, and please observe the following reminders:

• No electric/motorized bikes/scooters/skateboards/etc.



- 'Old fashioned' pedal-powered push bikes and scooters only.
- Please observe the **Road Rules** these are in place for everyone's safety this includes ALL ROAD USERS.
- Maximum Speed Limit is 8 kph this is basically walking pace.
- Please have consideration for **pedestrians** that may or may not hear you coming up behind them.
- Please let your **kids** know to <u>avoid</u> hanging around the amenities, especially the entrances, and not to ride through them, or the other common areas.
- These are **pedestrian access only**, and are used at any time of day or night by all ages of patrons, some of whom cannot hear or see as well as others (particularly at night), or have limited mobility.

Common Sense and Common Courtesy must prevail when staying in a busy Park!

A friendly reminder to ensure your **insurance policy is renewed before it expires!** As previously mentioned, it appears that some insurance companies have changed their processes and are requesting provision of more information than they used to: most commonly the VIN or Chassis number of the van.

Please ensure that the information you provide is correct, as if any information given (knowingly or unknowingly) that is incorrect may nullify and void the policy, rendering it invalid, which will leave you uninsured and in breach of the Occupancy Agreement.

Please remember **no works to be conducted during holiday periods**, and all works must be pre-approved by Park Management prior to any works commencing. This includes replacement items, repainting, and so forth.

If you are thinking of **sprucing up** / **repainting** / **replacing anything** / **etc**. on your van before the Summer holidays, please get your **Site Alteration application form** in for assessment in good time. The closer we get to the summer holidays, the less time there will be to get the works completed before the exclusion period comes into effect!

We'd like your help in trying to limit the places **rabbits** can hide and breed, by blocking in (as best possible) under the vans and annexes! If you intend to replace the skirting or add more, please submit an Alteration form giving details of your request.

Notifications:

Electricity meters will be read next week (commencing 09.09.24) and invoiced by the end of the week. Accounts



set to Automatic payments will be processed along with October site fees.

- **Daily supply charge**: 101.2 cents per day \times 180 / 4 (gtrs.) = \$45.54 charged on a guarterly basis
- Usage charges: 36.94 cents/kWh

Information regarding **PSC Smart Parking Permits for HVO's** is attached. If you are interested in applying for a Parking Permit, please read the attachment.

<u>02 4988 0990</u> – that's the number to call to contact the After Hours service to report any **after hours issues**. (NB: There are some issues that cannot be dealt with if we hear about it the next day: such as noise complaints or security problems.)

Parents and caregivers should ensure their kids know the park rules & are doing the right thing, and once again, please remember the **use of electric scooters and bikes**, **etc. are not permitted in the park**. **If you must have them here to use elsewhere**, **please WALK them out of the park grounds**.

We ask that such devices are **not charged onsite** as incorrect charging or damaged batteries/chargers can cause catastrophic fires. I shudder at the thought of a battery exploding/catching fire in a caravan park.....
